Home by Deltona currently have a total of 34 homes permitted and being built here in beautiful Sunny Hill's. Four of those homes are about 70% complete.

Reminder – All new construction (i.e. homes, accessory buildings, pools, etc), MUST apply through the Architectural Review Committee (ARC) for approval before going to Washington County Building Department. Site and construction plans may be dropped off at: 2277 Sunny Hills Blvd, Sunny Hills, FL 32428. The ARC Application Fee is \$125.00 and may be paid at the time of submittal with a personal or cashiers check.

Duration of restrictions is a question that we are tasked with answering on a daily basis. Please review the restrictions for your properties "UNIT" and see the "Duration of Restriction" paragraph. This paragraph states, that the "covenants and restrictions shall automatically be extended for successive periods of ten (10) years," etc. Basically what this is saying after the specific date, the covenants and restrictions renews every ten years. Therefore, they never expire, until the vote of the majority of the owners of the lot(s) or tract(s).

No animals, livestock or poultry of any kind shall be raised, bred, or kept on any lot, except that dogs, cats or other household pets may be kept, provided that they are not kept, bred or maintained for any commercial purposes. No Public Dumping - Violators will be prosecuted. If you see it, report it to Washington County Sheriff's Office by calling (850)638-6111. As you know, Sunny Hills is a large community. While we are working to visually inspect all areas within this community, your help is greatly appreciated!


